It would be odd if presupposed knowledge were totally unresponsive to rhetorical function, as rhetorical structure theory is used to predict a wide range of linguistic phenomena when applied to statements. They also demonstrate that presupposed knowledge is susceptible to rhetorical function and that a more rigorous concept of discourse updating should take the place of the idea of accommodation. We must first comprehend the essence of rhetorical activity in order to comprehend what a speaker is doing. Simply put, a rhetorical act is what a speaker says, along with the audience and the environment in which he says it (Harlow, 2021)
